### What is this product?

**Type** This product is a non-UCITS investment fund.

**Strategy** The investment objective of the product is to generate long term capital growth with a lower level of volatility than equity markets. The product seeks to attain its objective by diversifying investments in a number of collective investment schemes across different asset classes.

**Intended Investor** This product is best suited for investors who are willing to tolerate a medium to high level of volatility in the value of their investment. Investors should preferably have a time horizon of at least five years.

**Maturity** This product is open ended.

### What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 5 years. The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level and poor market conditions are unlikely to impact the capacity for you to receive a positive return on your investment.
