### What is this product?

**Type** This product is a non-UCITS investment fund.

**Strategy** The investment objective of the product is to generate long term capital growth from a focused portfolio of global equities of developed market, multi-national businesses (Blue Chips) with a market capitalization of \$5 billion or greater. The stocks will be listed on recognised stock exchanges in developed countries and will be held for a long period.

**Intended Investor** This product is best suited for investors who are seeking capital growth and are willing to tolerate the volatility levels of the equity markets in the value of their investment. Investors should preferably have a time horizon of more than five years.

**Maturity** This product is open ended.

### What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 5 years. The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level and poor market conditions could impact the capacity for you to receive a positive return on your investment.
